HUNTING AND FISHING LICENSE REFERENCE GUIDE

PRIVILEGES	APPLICATION NEEDED	REQUIREMENTS	MAIL TO DCNR
100% Physically Disabled Resident Hunting, Freshwater and Saltwater Fishing Licenses	YES	If disabled thru SSA, document must indicate that applicant is disabled, or receiving SSI or SSDI benefits and document must be dated within one year of purchase date. Resident ages 16-18 that do not qualify for disability thru SSA, must complete application and provide proof of disability (ex: current letter from medical doctor, etc.) The application and documentation must be faxed to DCNR for preapproval (334-242-3032). If disabled thru another entity, paperwork must be dated within one year of purchase date and state 100% disability.	YES, application, disability certification and DL
NR College Student Hunting and Fishing Licenses	YES	Complete application with appropriate certification by School Official, present a valid out-of-state DL & current student ID, must be 17-23 years of age, reside in Alabama and enrolled in an approved Alabama Higher Education Institute.	YES, application, qualifying documents, DL & College ID
Military Veteran's Appreciation Licenses for Hunting and Freshwater Fishing	NO	Agent must view document from Veteran's Administration indicating the applicant's % of disability. 100% for Hunting \$3.10 50%-99% Hunting \$13.85 20% or more Freshwater Fishing \$3.10	NO
Lifetime Licenses purchased by minors ages < 12	NO	Applicant must present two forms of residency from the residency flyer along with copy of a parent/guardian's DL, copy of birth certificate and SSN. (The SS card should not be mailed to Montgomery).	YES, the lifetime license sold & birth certificate

NEW We have made available a (1) *Physically Disabled License Report* and (2) *NR College Student License Report*. These reports can be printed by going to the 'REPORTING' page, enter your 'start and ending dates', then select the report from the drop down under 'report type'. The report includes the **(License Number * Issue Date * DL/NDL # * Licensee Name * License Status * Privilege Sold)**. *You should mail in the required documentation for all active licenses that appear on this report.*

We have made available the reprinting of a current year license and electronically issued disabled licenses that were purchased prior to 9/1/2015. To reprint you would need to visit our website at www.outdooralabama.com click, 'LICENSES' and 'print a license previously purchased'; enter the DL#, date of birth and last 4 of SSN. This process can be performed by the agent or the customer.

We make applications available for all privileges because some customers are required to or desire to mail their applications into the Montgomery Headquarters or Marine Resources Division. Applications are only required to be completed for Probate or License Commissioner's that purchase the 100% Physically Disabled Licenses or a NR College Student purchasing a resident license. However, if your internal policy is to have an application completed then you may do so but it shouldn't be mailed to Montgomery. Please refer to the chart above on documents that should be mailed.
