## The 1<sup>st</sup> rule when selling a license is to ask for the <u>Driver's License or Non-driver's ID</u> For the purpose of hunting and fishing licenses, residency is determined by the Driver's License Issuance

Under no circumstance shall a resident of another state (except military personnel) be issued an Alabama resident license even if that person is able to produce any of the Alabama residency documents.

## Age Requirements for Licenses:

- Residents: Ages 16-64
- Non-Residents: Ages 16 and over

## **Those Exempt from Purchasing a License:**

- Everyone under 16 years of age (resident and nonresident)
- AL residents 65 and over
- An Alabama Resident Landowner
- Military Resident home on leave (must have copy of leave orders)



# **MANDATORY REPORTING** OF DEER AND TURKEY HARVEST

Hunters are required to report their deer and turkey harvest through the GAME CHECK system. If you are one of the above hunters that are exempt from purchasing a hunting license then you would obtain the **GAME CHECK H.E.L.P LICENSE** in order to report your harvest. This license can be

obtained at any Probate or License Commission Office, any local license agent or at <u>www.outdooralabama.com</u>.

The DL# is not required for any minor 15 years of age and younger when selling a GAME CHECK H.E.L.P License.

### LIFETIME LICENSES

Lifetime licenses can be purchased by all bona fide residents of Alabama. If the resident has no DL or NDL they must provide at least two (2) of the documents listed below:

- Copy of school registration (required for school age children 5-16 years of age)\*\*\*\*
- Copy of previous year tax return (mailing address only)
- Voter Registration Card
- Certificate of Employment (if containing proof of permanent residency)
- Copy of home property tax
- Health insurance forms with address (Medicare) etc.
- The last three (3) months of a utility bill with mailing address
- Other legal documents may establish residency after approval by DCNR
- \*\*\*\*In addition to daycare or school registration the applicant should also provide a copy of the parent's driver's license as the 2<sup>nd</sup> residency document.

Please note that a birth certificate and social security card do not prove residency.
