# **Lifetime Disabled Veteran's Appreciation License**

## **Based on ages 16-49 and service-connected rating**

- **Hunting – 100% service-connected rating**
- **Hunting – 40-99% service-connected rating**
- **Freshwater Fishing – 20%+ service-connected rating**
- **Saltwater Fishing – 20%+ service-connected rating**

## **Based on ages 50+ and service-connected rating**

- **Hunting – 100% service-connected rating**
- **Hunting - 40% - 99% service-connected rating**
- **Freshwater Fishing – 20%+ service-connected rating**
- **Saltwater Fishing – 20%+ service-connected rating**

# **LICENSE DOCUMENTATION**

We have outlined the delivery method for documentation to DCNR. You should only send via email or mail, but not both.

- **Birth Certificates** for minors 11 years of age and younger purchasing a lifetime license.
- **VA document indicating service-connected disability rating & lifetime license application** – when issuing a Lifetime Disabled Veteran's Appreciation License.
- Reports should accompany documentation - this can be accomplished by
  - Select Reporting, enter start/end dates, select the following as your report type:
    - ***Lifetime Youth Report***
    - ***Lifetime Veteran Privilege Report***
- Please email the required documents on the day after purchase notating Birth Certificate or Lifetime VA in the subject line.
- Only email documents associated with the applicants listed on the reports above.

- **Disability certification paperwork & application** when issuing a Physically Disabled License – Annual.
- **NR College Student Application, Student ID and DL** when issuing licenses to fulltime college students aged 17-23 enrolled in an approved higher education facility in Alabama.
- **License Payment** – please make sure that your payment amount and the Business Summary Report amounts are the same if not, please provide documentation for the variance.



Please use the proper delivery method to provide documentation to us. Our staff must review all documents that we receive so it makes it difficult when we are receiving duplicate and excess paperwork. Please limit documents to those listed.

**Documents that should not be sent to DCNR:**

Disabled Veterans Appreciation Annual License, Regular Lifetime License Applications, Commercial Fowl Preserve Application, Lifetime License Replacements, Social Security Cards & Military Orders.
