### WHAT IS LEADS?

- LEADS is the Alabama Law Enforcement Agency Driver System
- One integrated driver license system that will replace and modernize numerous current systems
  - 8+ Systems involved in DL now, varying ages
  - Front Office Issuance System is over17 years old
- Automates many outdated manual processes, will allow ALEA to expand services which are currently limited
- Hardware upgrade
  - Computers, cameras, scanners, printers, card readers etc.
- Going Live April 26<sup>th</sup>, 2022



### **IMPORTANT CHANGES**

- Going to a single Driver License Number (DLN)
- Expanding Search ability (SSN, Address, and other)
- Change of Address and updating Voter Registration will be done online so the form will no longer be needed.
- New hardware at every office
- Background check truly done in the background
- Update emergency contact information
- Hardship applications will now be submitted online
- Expanding Online Services

- Online Renewals/Duplicates
- Submit Pre-Applications "New to Alabama"
- Update Addresses Online
- Purchase Motor Vehicle Records
- Purchase Crash Reports
- Upload DOT Medical Cards
- View TSA HazMat Background Check
- Access Reinstatement
  - Pay Fees
  - View Requirements
  - Generate Reinstatement Letters
- Virtual Assistant Trooper



### **DLW – DRIVER LICENSE WORKSTATION**

- New Computer
  - Windows 10
- New Monitor



- Lighting
  - Constant LED light replaces flash
- Facial Recognition







### SIGNATURE PAD AND CREDIT CARD READER

- Will be utilized for capturing the signature of the customer.
- Some County Partners utilize their own credit card partners, but they will still have to use this for capturing the signature.
- If using the ALEA credit card processor, new chip reader and tap to pay will be options.

### **LEADS TIMELINE**

- LEADS Goes Live April 26, 2022
- Office Closures
  - 76 ALEA DL Offices 100+ County Offices will have to be cut over
  - Online Services will come back up immediately
  - Customers with expiring DL/ID will be sent reminder letters to renew prior to the closure
  - 180 days before expiration, DL/ID can be renewed online

    - This will be done to update our existing system and to also populate the new system.
    - As always it is critical to notify ALEA when employee changes occur in your agency.
